This is a violent, decentralized pedophile extortion network that operates on Discord to coerce minors into self-harm and CSAM. They utilize Doxbin as a weapon to enforce silence; Fallbirds' access to Discord user data combined with Doxbin affiliation represents a catastrophic breach of user safety.

Specific Allegations of Grooming

Multiple victims have come forward with chat logs and testimony regarding Fallbirds' predatory behavior:

- **The "Meg" Incident:** Fallbirds is accused of grooming an 11-year-old user identified as "Meg". The dynamic involved manipulation typical of grooming, utilizing the power imbalance of being a "staff member" or "influential user" to isolate the child.

- **The Virginia Case:** Screenshots serve as evidence of Fallbirds admitting to a romantic/sexual relationship with a 17-year-old ex-partner located in Virginia.
 - *Legal Context:* In Virginia, the age of consent is 18, so this admission allegedly constitutes a confession to involvement with a minor under state law.
- **Harassment of Minors:** Reports indicate a pattern of targeting users under the age of 16, utilizing intimidation tactics when rejected.

- **Roblox Integration:** Predators often meet victims on Roblox and migrate them to Discord for unmoderated encrypted chat. Discord has allegedly failed to implement safeguards to break this "pipeline".

Discord's file-hosting architecture (CDNs) makes it a haven for Non-Consensual Intimate Media (NCIM).

- **The "CDN" Loophole:** Even if a user deletes an image, the direct link (CDN) often remains active, allowing revenge porn to be shared indefinitely.
- **Inconsistent Enforcement:**
 - *Policy:* Discord claims to ban NCIM (they do not even list on stopncii.org).
 - *Reality:* Users report that ticket submissions regarding revenge porn are often

auto-resolved or ignored. When action is taken, it is often against the *victim like in the case of angelfencer* for "participating in NSFW servers," or they claim set victim revenge porned him/herself while the distributor remains unpunished.

- **Sextortion Surge (2025):** Cases like the "Laules" extortion ring (coercing 84+ minors) highlight how predators use the threat of leaking images to keep victims trapped on the platform.

5. LEGAL PRECEDENT: RECENT LAWSUITS AND CONVICTIONS

For victims, the legal tide is allegedly turning against Discord with both civil lawsuits and criminal convictions. Civil Lawsuits Against Discord

1. Description of the Situation My child has been stalked online since around 2021 by a person who presumably lives in the United States. This person operates under various aliases on platforms such as Discord, Twitch, X (formerly Twitter), YouTube, and other social media. The stalker has been spreading false accusations for years, including claims that my child is a pedophile, and posts edited photos, threats, and slanderous messages. This happens repeatedly, even when my child creates a new account or switches to another platform. The stalker always manages to find them and defames them to their online friends, work contacts, and communities. This has led to severe psychological issues and social isolation. My child has indicated multiple times that they no longer see the point in living if this does not stop. There have been several suicide attempts.

2. Supporting Evidence A dossier has been compiled with: Screenshots of threats, slander, and stalking

Username and aliases of the stalker

Links to online messages and profiles

Timeline of incidents

Attempts to report to platforms (Trust & Safety)

Correspondence with support agencies

3. Previous Steps Attempts were previously made to file a report, but it was not processed due to the international nature and the use of aliases.

Reports have been made to the involved platforms, without results.

4. Request We urgently request the police to take this case seriously and investigate: Whether there are criminal offenses such as stalking, slander, threats, and identity abuse.

Whether international cooperation is possible to uncover the stalker's identity.

Whether protective measures can be taken for the victim.

Additional Context from Related Correspondence The following is a translated and redacted version of an informal letter/email seeking assistance, which appears related to the formal report above: "Hello [Redacted - Recipient's Name], This email I had sent earlier to an old email address.

But in the meantime, I have received the new details from a colleague at [Redacted - Company Name]. It has been a few years since we had contact about [Redacted - Victim's Name].

I now have an urgent request for help for my child and I hope that you can point us in the right direction where we can get help. [Redacted - Victim's Name] (Now [Redacted - Alternate Name] and transgender for several years) has been stalked in a very nasty persistent way online for about 4 years by a person from the US.

[Redacted - Victim's Name] 'lives' online, has their friends, work, activities, etc. there.

They are on various platforms such as Discord, Twitch, X, YouTube, etc., and the person stalking them has been spreading lies, photos, and threats about them for more than 4 years continuously.

[Redacted - Alternate Name] is at their wits' end and now at the point where they really do not want to continue with their life if this does not stop.

They are constantly accused of being a pedo and other slander, and if they go to a new place/platform"

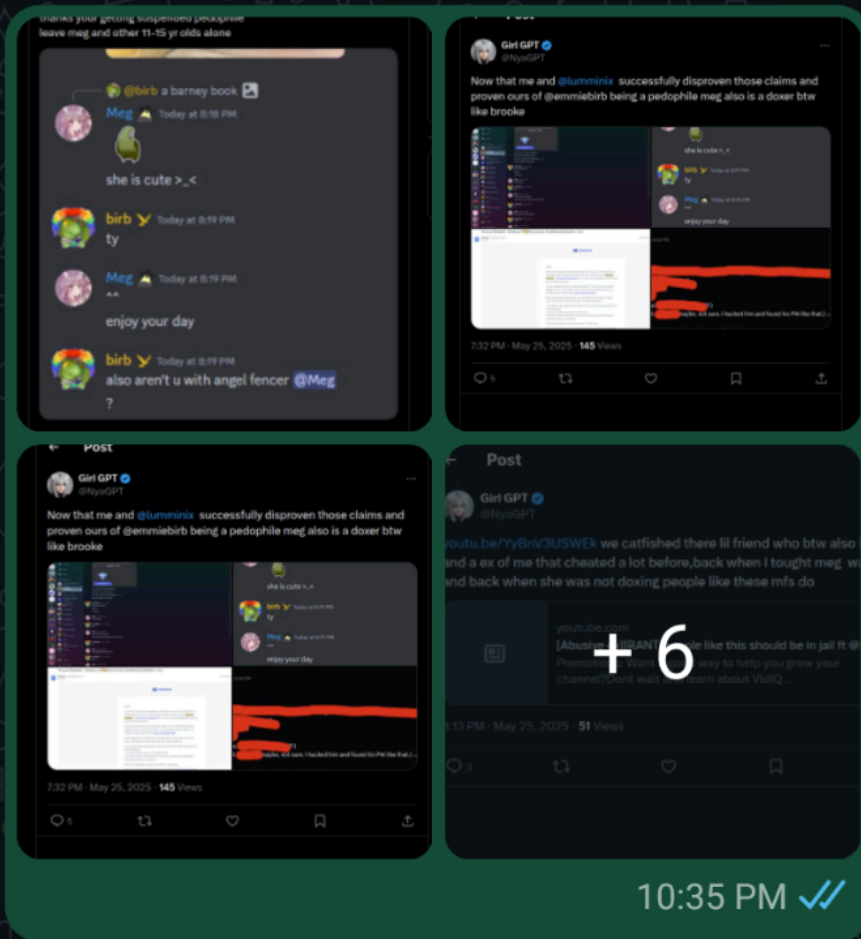

Formal Notice Regarding Alleged Unlawful Communications

It is hereby brought to attention that the repeated use of private (anonymous/blocked) calling features to contact an individual in large volumes may constitute a violation of applicable federal regulations, including those enforced by the Federal Communications Commission (FCC). Under U.S. law, specifically 47 U.S.C. § 223, it is prohibited to make telephone calls or utilize telecommunications devices anonymously (without disclosing identity) with the intent to abuse, threaten, or harass any specific person. Such conduct may also fall under prohibitions against transmitting misleading or inaccurate caller ID information with intent to cause harm, as outlined in the Truth in Caller ID Act.

The individual in question is alleged to have engaged in this behavior with the explicit purpose of harassing the recipient and, more gravely, with the stated objective of causing serious harm or endangering the recipient's life. If substantiated, such

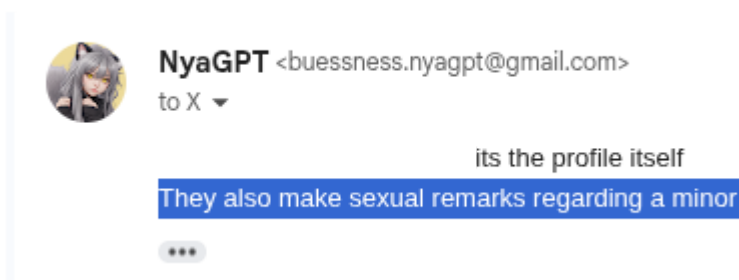
actions could expose the perpetrator to significant civil and/or criminal penalties, including substantial fines imposed by the FCC (potentially up to \$10,000 per violation in cases involving unlawful spoofing or related misconduct) or other authorities. Additionally, the individual is known to have engaged in extortionate behavior, including demands for valuable items such as beta keys (specifically, in connection with the game Hytale). In one documented instance, the recipient was allegedly coerced into providing a spare key under threat of blackmail.

Supporting Evidence Note:

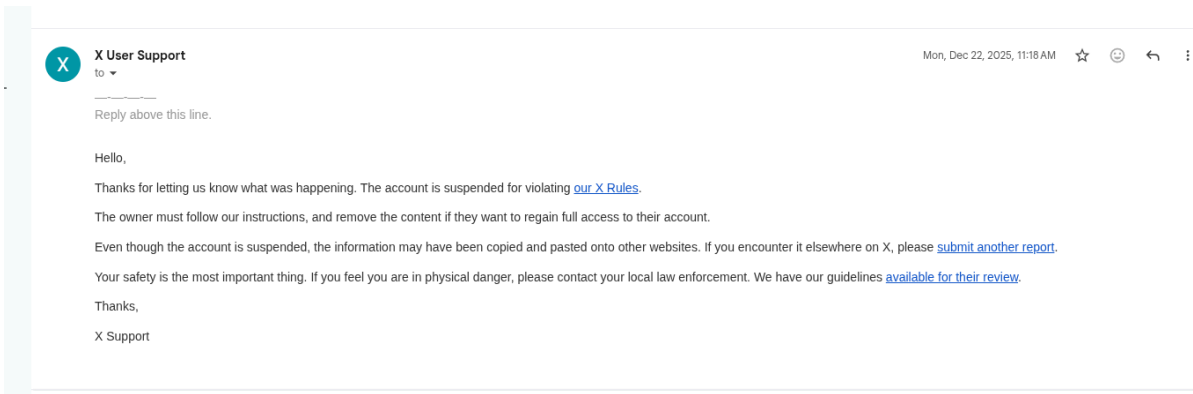
The attached screenshot depicts an SS7-level telephone log (originating from the recipient's Internet Service Provider / telecommunications carrier), which is highly uncommon for private individuals to obtain. This log provides detailed call records typically accessible only at the ISP or law enforcement level. It demonstrates the use of private calling to circumvent call-blocking measures and avoid number-based identification or restrictions. The log was originally in Dutch and has been automatically translated. For privacy and civil safety reasons, any police or emergency service numbers contacted by the recipient have been redacted. Should further action be required, it is recommended to preserve all relevant evidence (including call logs, screenshots, and communications) and consider reporting the matter to the appropriate authorities, such as the FCC (via [consumercomplaints.fcc.gov](https://www.consumercomplaints.fcc.gov)), local law enforcement, or other relevant agencies for investigation of potential harassment, threats, or extortion. This notice is provided in a factual and professional manner for documentation purposes.
